WATER STREET STREETScape IMPROVEMENTS

Sealed bids are invited and will be received by the City of Torrington, until 10:00 a.m., March 29, 2010 at the office of the City Purchasing Agent, "Temporary" City Hall, 59 Field Street, Torrington, Connecticut at which time and place they will be publicly opened and read aloud.

The project scope of the work includes the construction of streetscape improvements that include new sidewalks, curbs, landscaping, lighting, and some miscellaneous utility infrastructure. The limits of the improvements shall be the section of Water Street running from Main Street to Prospect Street. Work includes demolition of sidewalks, curbs and existing streetscape items. The scope of work requires the Contractor to develop detailed construction plans using the City's Concept Plan as a base plan incorporating criteria outlined in the project specifications. The Contractor shall submit plans to the City for approval prior to beginning construction. The necessary engineering services and associated fees for the work shall be included in the Bid amount.

Proposals must be submitted on the forms provided and in a sealed envelope plainly marked with the appropriate title.

A pre-bid conference to review the project will be held in the rear computer room at the Sullivan Senior Center, 88 East Albert Street, Torrington, Connecticut, on March 8, 2010, 1:00 P.M. All prospective bidders are urged to attend.

Attention of bidders is directed to certain requirements of this contract which require payment of Davis-Bacon wages, and compliance with certain local, state and federal requirements. This is a Federally funded project under ARRA. Contractors should be aware of special job creation retention and "Buy American" compliance and reporting requirements and other related conditions specific to the ARRA Act of 2009 provisions.

The Information for Bidders, Form of Bid, Specifications, and other contract documents may be obtained or examined at the City Purchasing Agent, "Temporary" City Hall, 59 Field Street, Torrington, Connecticut, Monday through Thursday 9 a.m. - 4 p.m. A \$50.00 non-refundable deposit payable to the City of Torrington will be required of all prospective bidders.

Bids, to receive consideration, must be in the hands of the authorized representative, no later than the day and hour mentioned above.

The City of Torrington reserves the right to accept or reject any or all bids; to waive any informalities, or; to accept any bid deemed in the best interests of the City of Torrington.

All bids will be considered valid for a period of ninety (90) days.
