

## SHOULD YOUR NAME BE ON THE TORRINGTON VETERAN MEMORIAL WALL

The Desert Storm Veteran Memorial Plaque on the Memorial Wall at City Hall is being updated in April. If you are a Veteran of the Desert Storm Era, were a Torrington Resident when you entered the service, served at least 90 days active duty and were honorably discharged, you're probably eligible to be listed on the Memorial Wall.

This is the final update for the Desert Storm section as no names will be added after the completion of the Desert Storm update. If you think you are eligible, contact the City Clerk's Office at 140 Main Street, Torrington, CT 06790.

You must supply a DD-214 for proof of eligibility.
